## Benefits of Membership of the Chamber

Membership in the Chamber of Advocates Malta is open to all warranted Maltese lawyers, as well as lawyers from EU countries who are duly registered with the Ministry for Justice.

The annual membership fee is valid for every calendar year, i.e. 01 January until 31 December and is automatically renewed unless the Chamber is advised, in writing, to the contrary, not later than 30 November of the current year.
